## Background

Alberta Education has provided an annual grant of \$716,000.00 per year for three years (2008-2009; 2009-2010; 2010-2011) for school jurisdictions in the Edmonton Regional Learning Consortium (ERLC) region to provide curriculum implementation support, which aligns with Alberta Education's Curriculum Implementation schedule. The grant deliverables request that a comprehensive plan that meets the expectations of Alberta Education and matches the needs and direction of zone three districts is developed.

This report provides an overview of the programs and services ERLC provided to the region to support implementation.

ERLC's work is influenced by beliefs represented in the ARPDC curriculum implementation beliefs: effective collaboration, effective practice and effective adult learning.


## **Regional Characteristics**

- District staff that must travel a distance to attend sessions in Edmonton, (e.g., 6 districts include schools more than 3 5 hours away from Edmonton).
- Districts that are increasingly using technology to access professional development (e.g. video conferencing).
- Jurisdictions with limited access to supply teachers (e.g. rural).
- Districts that have a significant percentage of new teachers including teachers from out of province who are not familiar with the Alberta Program of Studies (e.g. Fort McMurray, Northern Tier district).

Initial conversations about the 2009-2010 plan began in March 2009 at a meeting following the CASS Curriculum Symposium. The group provided advice and direction to the building of the regional implementation plan; and will provide ongoing feedback about the plan, communicate the intent of the plan, gather evidence of success within their organizational network, identify future regional needs based on district needs and collaborate together to share lessons learned. ERLC facilitates 8 – 10 different advisory committee meetings that meet between 2-3 times a year. The fall 2009 meetings provided advice and direction for program planning. Executive Directors work collaboratively and meet formally between 4 – 6 times per year. Informal meetings, including emails, phone conversations and webinars are very frequent!



### Highlights 2009-2010

- K-10 teachers in the ERLC region had access to a wide variety of learning opportunities that
  included face to face sessions, cohort planning groups, and access via videoconferencing,
  webinars, and webcasting. These learning opportunities took place mainly during the day, but
  also included supper and summer sessions. Very few of the learning opportunities were
  cancelled. Conversely, learning opportunities were added based on teacher feedback and
  request. An example would be that one four day planning cohort was planned for Mathematics
  10C. When that was fully subscribed a second four day planning cohort was added. The result
  was that many teachers across the region worked with mathematics facilitators to learn about
  and reflect on their mathematics classroom practice. In total 80 full day learning opportunities
  were provided.
- How do we know that implementation is occurring? This question is constant in all discussions within the ERLC region. In addition to quantitative data such as numbers of learning opportunities and numbers of participants, ERLC collects qualitative data which provides a

glimpse into some of the rich conversations that are occurring among teachers as they reflect on the new curriculum and what it looks like in practice in their classrooms. The following videos are intended to provide only a few examples of the conversations and reflections of classroom teachers around such topics as how to develop conceptual understanding with their students.

- Participant feedback has been very positive. In particular, the ERLC received a great deal of feedback on the mathematics institutes that were led by Cathy Fosnot. Some of the feedback included... she said she spent the whole morning with one of the two classes she teaches and the kids remained engaged. C was so excited that we put a PowerPoint presentation together to present at the next staff meeting and this morning at our Math Lead Teacher Meeting, BR (who attended Cathy's session) did a presentation on the session. She was so enthusiastic and felt it was a fabulous session. She was so keen that she contacted Pearson and borrowed the K 3 box of Cathy's materials to show and she even made up a PowerPoint. She is already using some of the things she learned from Cathy in her classroom. Thought you might be interested in hearing about such a positive response to the session.
- Senior High Mathematics Institutes were held in January and June of 2010. The January Institute was hosted by the Calgary Regional Consortium. It was videoconferenced out to 12 sites across the province and involved over 500 senior high mathematics teachers. The Edmonton Regional Learning Consortium hosted the June institute and webcast out to 12 sites across the province. Different technologies were used to determine which might be most appropriate as we continue to plan ongoing senior high provincial mathematics institutes. The same speaker was highlighted in both institutes and this has generated a great deal of discussion and "trying out" different strategies in high school classes across the region.
- The ERLC mathematics advisory committee provided ongoing crucial advice and support implementation of mathematics in the ERLC region. The committee provided advice and feedback not only about the structure and content of the plan and ongoing refinement of that plan but also about the use of emerging technologies to provide greater access to professional learning for all members of the region and beyond. In particular, the use of videoconferencing and webinars gained greater prominence during the course of the year. This did require greater resources but did also provide greater access for all teachers not only because of the use of the technology to deliver the session but also because many of these sessions were recorded and archived for ongoing use. As a member of the committee, Lori Weinberger in Ft. McMurray noted: *In response to the question that was posed regarding evidence of ERLC support for implementation:* 
  - o alignment of ERLC math sessions to my district's comprehensive PD plan
  - o the support of the PD offerings provided locally (e.g. our district PD day in January)
  - opportunities for collaboration across our region on common issues (assessment/report cards)
  - o development of resources that support local implementation (parent newsletters, tool kit)
- The mathematics regional team consisting of the ERLC mathematics coordinator and four consultants from Edmonton Public Schools was able to provide in district support to ERLC districts. Each district had access to three days of consulting time and a number chose to work together and pool their days. The efforts of the team were greatly appreciated by the region. An example of a comment from a district: *I just wanted to let you know that the math inservice at Westhaven yesterday was awesome!! Cathy Campbell knew what (as teachers) we would want. Everything was practical and we can use it in our classes.*

#### Lessons Learned 2009-2010

- Choice and variety are key elements in providing learning opportunities that meet the needs of teachers.
- The use of technology helps to mitigate time and distance however the use of videoconferencing, webcasting, and webinars does require extra time to prepare facilitators and support participants in "being connected". Presenters are not always experienced or comfortable with the emerging technologies and often need extra support in preparation. Technical support is not always readily available and so careful work is done in preparation to test connections and make sure that everything is working as much as possible in advance.
- Participants indicate the value of cohort planning groups but sometimes find it difficult to take time away from their classes. This is particularly true for senior high teachers working on semestered classes. At the same time many teachers are not yet familiar enough or comfortable enough with technologies such as webinars to participate in large numbers. Continued support and development will be needed to enhance the use of these technologies. Careful consultation and planning will need to continue in planning all programs, in particular using emerging technologies to delivery learning opportunities.
- Implementation takes time. As implementation continues teachers are coming forward with different questions and different needs than were expressed in pre-implementation or during the first year of implementation.


#### Highlights 2009 - 2010

- A key accomplishment this year was partnering with the ATA ESL specialist council on their conference as well as the planning and delivery of a series of webinars. Working with specialist council representatives a district leader and the ERLC distributed learning consultant a program was developed that supported the region with areas of focus and need they identified. The webinars also provided sustainable support for those teachers that have few ESL students and want to learn more but are unable to attend PD. (e.g., lack of resources, time, travel, suitability of date session offered) The archived webinars are on the ERLC site at http://www.erlc.ca/resources/default.php?theme=54&title=English+Language+Learners as well the ATA ESL specialist council plans to add these resources to their website.
- This project developed capacity of ESL leaders in the province who are now comfortable and very capable in delivering learning opportunities via webinar.

#### Lessons Learned 2009 - 2010

• Collaboration takes time and we are thankful that we could access the busy schedules of the leaders that offered these webinars. Training these leaders on the ways that presentations needed to be adapted for a webinar, practicing the process with them as well as piloting the session prior to offering live was time intensive. They were thankful for the learning with positive comments on file.

- Delivering learning opportunities using this technology was a "match" between need, audience and the medium used. There are many teachers who only have one or two esl students in a class who are not able to attend full day pd. Webinars provide an opportunity to access the learning any time, pace and place.
- The webinars are "robust" with a lot of information and have been accessed by some. We need to determine ways to further advertise what is available and consider developing "conversation guides" that offer support for those that wish to use these archived resources to facilitate conversations with their plc or staff group.

#### Highlights and lessons learned 2009-2010

There was limited interest in attending the international/second languages advisory committee this year. When asked, districts shared that there were multiple priorities and few international language teachers. Sessions offered had low attendance but were appreciated by those that attended who shared they valued the opportunity to network across districts. The two large urban boards in the region have the highest number of second language programs and provide consulting service for those teachers. Collaborating with Alberta Education – specifically for the Spanish Teachers Seminar and Resource Fair was a success and reminds us about the need to partner in areas where the audience is specialized. Partnering with EPS IISLE group has been successful and one example is the "off to a good start" program where second language teachers can access two days of learning about programming. This model brings teachers/districts from small sites together with the large urban boards who have larger numbers of teachers in this speciality area.

## Highlights 2009-2010

- A learning opportunity provided during semester break in January was most well attended with approximately 50 participants.
- Choice and variety in types and formats of learning opportunities was offered to senior high science teachers in the region. Face to face physics and technology sessions seemed to be of greatest interest to teachers.

## Lessons Learned 2009-2010

- Teachers feel that it is difficult to leave their classes. Using times like semester break may help maximize the opportunity for teachers to participate in professional development.
- Learning opportunities planned for evenings with opportunities for videoconference access have not been well accepted or attended in the ERLC region.
- There seems to be a greater need for professional development support in physics and the use of technology to engage students.
- Although a number of learning opportunities were planned in conjunction with CMASTE and Kings University College many did not run due to low numbers. Greater efforts might be made to work

more closely with the ATA specialist council.

### Highlights and Lessons Learned 2009-2010

- The Edmonton Regional Learning Consortium was able to offer learning opportunities, which were well attended, for teachers in social studies and mathematics both at teachers' conventions and through the ERLC calendar.



#### Highlights and Lessons Learned 2009-2010

Resources for this focus area came from the distributed professional learning grant. Multiple technology integration sessions were offered that focused on learning how to use tools as well as supporting program of studies implementation and student learning through use of technology resources. Learning opportunities were developed based on the research-based TPACK model, an approach to effective technology integration that works with any type of instructional planning. It is a learnercentered, outcomes-based planning approach in which technology supports learners meeting the outcomes in ways that make the most sense. Smart board sessions continued to "Sell out" with a continued focus on embedding this tool in a pedagogical approach in support of student learning in specific subject areas. Webinars as a distributed learning method have become increasingly popular to the point where we have had to train two additional teacher-contractors as moderators as well as increase the capacity of our in-house staff to support this new form of distributed professional learning. Another way we have worked to create capacity within our region is via the creation of both SMART and Promethean PD resource packaged for leaders who train others. To help implement these resources, various sessions were held across the region, and archived webinar sessions have been posted on the ERLC wiki http://erlc.wikispaces.com/SMART+Board+Implementation+PD+Resource . The ERLC wiki was designed to support ongoing professional learning by providing webinar archives with time-coded tables of contents, conversation guides, presenter's slides and related resources for use by PLCs, instructional coaches and individuals in a flexible format that allows learning to continue anytime, anyplace at any pace.

#### Highlights and Lessons Learned 2009-2010:

Limited sessions were offered in this area based on requests from the region. One challenge is that when classroom teachers are "trained" to deliver specific sessions it may sometimes be difficult for them to get time away from their schools to share that training with others. ERLC was able to successfully offer one safety session during the year. That session was offered in the context of a Career and Technology Studies Professional Development day planned in conjunction with Edmonton Public and Edmonton Catholic Schools. The day took place at the end of January 2010 and offered 23 sessions to approximately 200 CTS teachers from the ERLC region.





# Supporting Implementation is a Shared Responsibility

Successful implementation is possible in environments where education stakeholders are committed to sharing the responsibility for supporting implementation within a culture of learning.

### Shared Responsibility

Shared responsibility is a commitment among education stakeholders – Alberta Education staff, school boards, jurisdictional and school leaders, teachers, professional learning<sup>s</sup> providers, students, parents, and school councils – to develop a shared understanding of and commitment to their respective roles and responsibilities to support implementation. In some cases education stakeholders' implementation support responsibilities might be shared, in other instances they will have distinct responsibilities.

### Culture of Learning

A culture of learning is a social/emotional environment in which inquiry, risk-taking, sharing and collaboration are encouraged in order to optimize student learning.




Figure 1. Essential Conditions to Support Implementation

# Essential Conditions to Support Implementation

Successful implementation is possible when education stakeholders share responsibility to address the seven essential conditions shared vision, leadership, research and evidence, resources, teacher professional growth, time, and community engagement. Figure 1 names the seven essential conditions (blue circles), identifies the education stakeholders involved in collaboratively addressing these essential conditions (green fins), and depicts the culture of learning within which educational policies, curricula, programs, initiatives, and priorities are implemented (orange circle).

5 Professional learning is based on a model of continuous improvement that acknowledges career-long growth and development. It involves interactions and caliabantions among educators engaged in a learning community, and is best supported by comprehensive professional growth plans that consider those conditions essential to successful implementation. The terms professional learning and professional development (or PD) are used interchangeably in this guide.

# **Planning for Successful Implementation**

Planning for successful implementation requires an understanding of the characteristics of successful implementation; coherence among plans and priorities; and the intentional efforts by education stakeholders to collaboratively address the essential conditions.

## **Characteristics of Successful Implementation**

As education policies, curricula, priorities, programs and initiatives evolve, they need to be successfully implemented to ensure student learning success. Research shows that successful implementation

- is a shared responsibility among stakeholders;
- is developmental and contextual;
- is systematically planned, systemic, and sustained;
- is meaningful, purposeful and focused on key priorities;
- involves learning opportunities that focus on enhancing professional practice and leadership capacity among educators<sup>6</sup>;
- involves a variety of learning opportunities by and for all education stakeholders including support staff, students, parents, school councils and community members; and
- involves change at both organizational and individual levels.

# Successful Implementation Requires System Coherence

Successful implementation is complex work requiring coherence among several plans and priorities. Provincial policy requires that all certificated teachers develop annual **professional growth plans** based on self-assessments of their learning needs relative to the *Teaching Quality Standard*. School boards and jurisdictions<sup>7</sup> are required to develop annual **education plans**. Professional growth plans and annual education plans also need to align with evolving **provincial education goals**. Annual education plans need to specify how jurisdiction professional development plans will support implementation of school board and provincial goals. Figure 2 illustrates the need to build coherence among all of these plans to improve professional practice focused on enhanced student learning.



# Addressing the Essential Conditions

Intentionally addressing the essential conditions requires that education stakeholders collaborate to

- answer several guiding questions as they develop their implementation plans;
- use a variety of implementation strategies that identify who will be responsible for what, by when and at what cost; and
- establish what evidence will be accepted that the essential conditions have been addressed.

Implementation planning templates and tools focused on addressing each of the essential conditions are provided on the following pages.


